## LAW STUDENT AND LAW GRADUATE PRACTICE

### REQUEST FOR LAW GRADUATE PRACTICE CERTIFICATE

Under the recently updated <u>Rule 14-807</u> of the Rules Governing the Utah State Bar, law students and law graduates may be eligible to participate in certain administrative, civil, and criminal proceedings. Those interested in participating should read <u>Rule 14-807</u> carefully.

A current law student who wishes to practice under the rule does not need to contact or file any documentation with the Bar to participate. The law school and the supervising attorney will be responsible for ensuring the eligibility of the student to practice.

A *law school graduate* who wishes to practice under the rule must file a **Law Graduate Assistance Form** (see below) with the Admissions Office of the Bar and wait to receive a **Law Graduate Practice Certificate** from the Bar. The graduate may begin practice as soon as she or he received the Certificate.

### Summary of required qualifications

#### For a law **student** to be eligible, she or he must:

- 1. Be a student in good standing at an ABA-approved law school;
- 2. Have completed at least the first year of legal studies (at least 2 semesters or the equivalent);
- 3. Be enrolled in a law school clinic or externship OR be a volunteer or employee at a taxexempt or governmental agency or at a for-profit entity;
- 4. Be supervised by an attorney authorized to practice law in Utah;
- 5. Have passed a course in evidence (if the student intends to appear on behalf of a client at a deposition or evidentiary hearing); and
- 6. Have passed a course in criminal procedure (if the student intends to appear at a criminal evidentiary hearing).

A law student must immediately cease practice if there is a change in circumstance so that she or he no longer meets one or more of the above qualifications.

#### For a law **graduate** to be eligible, she or he must:

- 1. Have graduated from an ABA-approved law school within the last 18 months;
- 2. Be taking a regularly scheduled Bar examination within one year after graduating;
- 3. Be working under the supervision of an attorney authorized to practice law in Utah;
- 4. Have passed a course in evidence (if the graduate intends to appear on behalf of a client at a deposition in the presence of the supervising attorney).

A law graduate must immediately cease practice if there is a change in circumstance so that she or he no longer meets one or more of the above qualifications or if any of the following occurs: she or he fails to submit an application to the Bar within a year of graduation; the Character and Fitness Committee or Admissions Office denies the graduate permission to take a bar examination; the graduate fails to pass the bar examination on the second attempt; or the graduate fails to be fully admitted within 6 months of passing the bar examination.
