PRACTICE PENDING ADMISSION TO THE UTAH STATE BAR

Under <u>Rule 14-809</u> of the Rules governing the Utah State Bar, applicants for admission who are transferring a UBE score under <u>Rule 14-712</u> or who have been <u>licensed and practicing full time for 36 of the last 60 months in another</u> <u>jurisdiction</u> may practice under supervision of an active Utah attorney while awaiting the approval of her or his application. Those interested in participating should read <u>Rule 14-809</u> carefully.

The applicant must first 1) file a complete Application with the Bar, 2) file a signed *Practice Pending Admission Request Form*, and 3) once approved by Admissions for a Certificate, pay a \$100 fee, which is payable through your account on the Admissions website. **Incomplete applications including missing documentation will delay the process.**

Once the Bar receives the required forms, payment, and confirms the Applicant's eligibility, then the Bar will issue the *Practice Pending Admissions Certificate* to the attorney. The attorney may then begin to practice law in accordance with the Rule.

An Applicant must **immediately cease** practice if there is a change in circumstance so that she or he no longer meets one or more of the qualifications or if any of the following occurs:

- 1. the lapse of one year since the issuance of the *Practice Pending Admission Certificate*;
- 2. the attorney withdraws the application for admission;
- 3. the Character and Fitness Committee or Admissions Office defers or does not approve the application for admission; or
- 4. the attorney fails to pass the Utah Bar examination.

Attorney applicants who do not meet these qualifications are NOT permitted to practice law from an office in this state until they obtain a Utah license (*see* <u>Rule</u> <u>14-111 Practicing without a license prohibited</u>, <u>Rule 14-802 Authorization to</u> <u>practice law</u>, and Rules of Professional Conduct <u>Rule 5.5 Unauthorized Practice of</u> <u>Law</u>; <u>Multijurisdictional Practice of Law</u>). Please note that neither the Bar nor its representatives have the authority to waive the requirements contained in the Rules.
